**1. Amendments to the Prospectus**

Since the lodgment of the Prospectus, there has been a change in circumstance with respect to the 6 agreements registered on the title of ML86 and ML87 disclosed in the "title risk" section on page 80 of the Prospectus.

In particular, the Company notes that the NSW Department of Industry Resources & Energy confirmed in a letter dated 3 November 2016 that in response to the application by Broken Hill Prospecting Limited, in accordance with section 161(6) of the *Mining Act 1992* the registration of each of the 6 agreements on the title of ML86 and ML87 has been terminated. This was confirmed by searches undertaken in respect of ML86 and ML87 on 7 November 2016.

**2. Directors' belief**


The Directors believe that the information contained in this Supplementary Prospectus is not materially adverse from the point of view of an investor.
