- Our highest priority is the health and safety of our people, contractors, their families and the communities in which we operate
- BPL has entered this period of volatility in a strong financial position with increased financial resilience that has been developed over the past two years as we have prepared for the development of the La Paz Rare Earth Project in Arizona, North America.
- The directors have reviewed a number of its existing contracts with a view to finding additional cost savings which together with health and safety measures, will ensure the wellbeing of our people and our company.
- The company has closed its Sydney office and implemented a "working remotely" policy for all Directors and support personnel
- During this period of considerable change, the company continues to operate as normally as is possible and remains focused on ensuring business continuity and the uninterrupted post exploration development of La Paz
- BPL remains focussed on the economic recovery post COVID-19 and is taking steps to preserve cash until year end
- These financial and operational measures are aimed at assisting BPL work through the current environment, and to allow geological reviews and desktop activities to continue on our La Paz Rare Earth Project
